UPDATES AND COMMENTS:

Chester County Environmental Alliance:

Ms. Cadorette presented information to the board about the Chester County Environmental Alliance (CCEA). CCEA is an alliance of about 25 independent organizations that work together to protect and enhance the environment in Chester County. Planning Commission Director's Report:

Mr. O'Leary noted that the county's comprehensive plan *Landscapes3* includes environmental metrics and tracking for actions that take place within the preservation and environment goals. These metrics will be presented at the Planning Commission's July 8, 2020 board meeting and will be shared with the Environmental and Energy Advisory board.

Other Updates:

Ms. Bowers mentioned that the Chester County Water Resources Authority is in the process of updating the county's stormwater management and integrated water resources management plan. Due to Covid19 restrictions, the stakeholder process was interrupted, but the update of the plans is again moving forward.

Ms. DeWolf mentioned that the West Chester Area Council of Governments completed the West Chester Area 100% Renewable Energy Transition Study also known as the "Cadmus report". The report can be found here: https://eastgoshen.org/wp-content/uploads/2020/03/WCACOG-100-RE-Study final-3.4.pdf

Public Comment:

Ms. Cadorette read a comment from Mr. Keffer, Engineer with Light - Heigel and Assoc. for the Devault Foods Final Plan. Devault Foods is proposing a significant expansion of their industrial activity on their site in Charlestown Township. Mr. Keffer wrote, "We were listening to make sure your committee was not proposing any type of cogeneration or alternative energy requirements for plans that expand energy usage in the County."
